In fact, when we compare ourselves to non-selective independent and state schools in the UK we came  $3^{rd}$  in the league tables for GCSE and  $13^{th}$  for A Level. #### Summary of Offers:

Students from BSAK took up places on a wide range of universities and courses in 2016 from Fashion Marketing to Medicine and Journalism to Chemistry.

78 students went to the UK, 9 to the US, 3 to Canada, 2 to the UAE and 1 to the Netherlands. In the UK 41 (52%) went to Russell Group Universities with 3 reading courses at Oxbridge. In the US 2 students have gone on to Ivy League Universities of Harvard and Cornell.

## Financials

This Honorary Treasurer's Report, together with the Report and Accounts for the financial year ended 31st August 2016 prepared by Ernst & Young in accordance with International Financial Reporting Standards as issued by the International Accounting Standards Board, has been posted to the School's website and will be available for review there.

For the year ended 31st August 2016 the School reported an accounting loss of a little under AED 550 thousand, a very considerable improvement on the previous year's accounting loss of just under AED 3 million, in turn a much better result than that in the preceding year. The loss this year was expected, given the Abu Dhabi Education Council's (ADEC's) decision to decline the School's application for a fees increase in the year 2015-16. For the financial year just ended the loss was relatively modest and of limited concern in the context of the School's cashflow and scale, but the Board is keenly aware of the need to continue to build cash reserves to meet capital expenditure requirements as these become necessary. Our continuing model as a Not-for-Profit community school is to keep fees low and to manage them over extended business cycles such that there are no sharp fee increases and costs are controlled, but with a clear, maintained focus on quality of provision. Therefore it is very probable that the Board will seek a fees increase for the year 2017-18 after two years of no increases in an environment where costs are continuing to rise. Nevertheless, my expectation is that our fee levels will continue to compare very favourably with our peer group.

Whilst revenue was slightly down, I am pleased to report that this was more than offset by savings in staff costs and reduced finance costs, combined with much lower depreciation. However, such reductions cannot be continued every year and we would expect costs to stabilise at current levels, subject only to inflation.

The balance sheet is robust and the School has been conservative in its policies as regards end of service benefit provision, depreciation and asset/liability matching among other things; and for the short to medium term the School is therefore in a strong position.

The School's student roll remains at over 1840 students, slightly down from the previous year's record high of 1865 but continuing to run, as for many years now, at more or less full capacity; our waiting lists remain very healthy. As a Not For Profit School, which ploughs all revenues into education and which has no shareholders, we have been very careful to husband cash meticulously over the last 9-10 years and have now achieved a healthy overall position. Our liabilities are primarily long-term in nature and we remain satisfied with our gearing, notwithstanding our prudential wish to rebuild equity. As noted in my previous year's report, we identified at the start of the current business cycle four key financial principles around leverage, cash reserves, liquidity and our long term financial health. I am pleased to report that we have made consistent progress against these indicators. Notwithstanding this progress, we are not complacent and recognise the challenges posed by the prevailing economic backdrop in Abu Dhabi.

Over the last two years we have made several changes and simplifications to our compensation package for staff to ensure that we continue to attract and retain a very high calibre team. This programme is largely complete. As reported last year, we are introducing new systems in the HR and Accounting areas but this will be at low cost and with minimal disruption for parents.

As Honorary Treasurer I wish to convey my thanks to my colleagues on the Board and in the Finance and Premises Committee; and to our Finance and Operations Managers and their hard-working teams.


